## **Listen 4 Change: What We've Been Up To in November**

- We attended a regional meeting with Parent Carers Forums from across Cheshire & Merseyside to discuss the progress of the implementation of the ND (Neurodiversity) Profiling Tool
- We participated in a Preparing for Adulthood Journey Workshop organised by St Helens Council and facilitated by the National Development Team for Inclusion to explore how local services support young people with SEND into employment and to identify areas for development in order to improve employment outcomes for young people with SEND
- We welcomed St Helens Council's Inclusion Manager from the Education and TESSA Team to our coffee morning to share information, to listen to feedback and to answer parent carers questions
- We attended the Autism in Schools Steering Group meeting to discuss action plans and training for schools and to hear updates on the ND Profiling Tool and from TESSA Autism
- We attended the Cheshire & Merseyside regional meeting of Parent Carer Forum Leads to discuss arranging focus groups to gain an insight into access to dental care for children and young people with SEND, the establishment of a regional model for diagnosing learning disabilities (LD) and services available to support those with a LD diagnosis and the All Together Smiling intervention used in education settings to support children with developing good oral health
- We attended a project meeting to discuss the sensory equipment ordered and updates on the progress made for launching Haydock library as a SEND-friendly library
- We attended a Cheshire & Merseyside regional workshop of professionals to share parent carers thoughts on the implementation of the ND Profiling Tool
- We attended a coffee event at Eccleston Mere Primary School to speak with the SENCO and parent carers about Listen 4 Change, what we do and services available locally to support parent carers and their children and young people with SEND
- We held a coffee evening to chat with other parent carers about what's working well for our children and young people with SEND and what needs improving

**Government Consultation on Down Syndrome Act 2022: draft statutory guidance**

This relates to people with Down Syndrome and those with other conditions or a learning disability who have similar needs.

As a result of the Down Syndrome Act 2022 statutory guidance has been drafted to inform services - such as healthcare, social care, local councils, education, employers and housing services - of the actions they should be taking to support the needs of people with Down Syndrome and those with other conditions or a learning disability who have similar needs.

This draft guidance brings useful information together in one document and aims to help improve support for people with Down Syndrome and those with other conditions or a learning disability who have similar needs to live fulfilling lives through accessing the health and care services they need, receiving the right education, securing living arrangements that work for them, and enabling proper employment opportunities and support.

The consultation period closes on 28th Jan 2026. Following which, the Department of Health & Social Care will review all responses and will publish final Down Syndrome Act 2022 statutory guidance which relevant services will then need to have due regard to.

## **St Helens Council Scrutiny Review of SEND School Provision in St Helens**

Thank you to those parent carers that attended the Listen 4 Change meeting on Tuesday 9<sup>th</sup> December and shared your views with the Task & Finish group from St Helens Council's Children and Young People Services Scrutiny Committee regarding the demand for school places for children and young people with SEND and the barriers to ensuring that provision is suitable to enable positive outcomes for children and young people.

For those parent carers that were not able to attend the meeting, we would encourage you to contact the Scrutiny Team at [scrutiny@sthelens.gov.uk](mailto:scrutiny@sthelens.gov.uk) to share your views on the:

- current state of SEND provision in the Borough,
- whether existing provision is meeting the needs of your child or young person with SEND,
- what could be done to improve the provision of suitable support for pupils with SEND.

We'd suggest you title your email "Scrutiny Review into SEND School Places" so it reaches the right Task & Finish Group. The task group will finish their review in January, a report will be prepared and presented to the Scrutiny Committee in March recommending actions that can be taken and will then be agreed and submitted to Cabinet for consideration.

**Neurodiversity profiling tool**

NHS Cheshire & Merseyside are launching a new neurodevelopmental pathway and vision for how services across Cheshire and Merseyside can better support neurodivergent children and young people. One of the proposed changes is the use of a neurodiversity profiling tool to provide a holistic view of a child/young person's needs and to help identify strategies or further sources of support to help manage those needs. The profile will be completed by a professional in collaboration with parents and the child/young person (if appropriate).

# ARE YOU IN NEED OF URGENT DENTAL CARE OR ADVICE? THEN WE CAN HELP!

The CWWM Dental Helpline offers urgent dental care for patients in Cheshire, Warrington, Wirral and Merseyside. The service can be accessed via the Dental Helpline on 0161 476 9651 from 8am to 10pm every day, including weekends and Bank Holidays.

**Service operating 8am-10pm, 7 days a week**

During the 'in-hours' period (08:00-18:00 hours Monday to Friday), if you already have a dentist you should contact them directly. If you do not have a regular dentist then the Dental Helpline will triage your call, give advice and guidance to manage your dental problem or assist you to find an appointment, as long as you meet all the eligibility criteria.

During the 'out of hours' period (18:00-22:00 Monday to Friday, Weekends and Bank Holidays 08:00-22:00) our call handlers and dental nurses can provide advice and support for all patients, whether they have a regular dentist or not.

#### **What happens between 10pm and 8am?**

Patients can still call NHS 111 for urgent dental advice. If patients do call NHS 111 with a dental issue between 8am and 10pm they will automatically be redirected to the dental service.

#### **PLEASE NOTE:**

The service is provided according to strict clinical criteria.

The service is only available for urgent dental problems such as trauma, facial swelling, uncontrolled bleeding or pain that is persistent and is not being controlled by pain relief.
