## **Listen 4 Change: What We've Been Up To in December**

- We attended training sessions ran on behalf of NHS Cheshire & Merseyside to help parent carers understand the Neurodiversity Profiling Tool and how it will be used to better support neurodivergent children and young people. This was helpful in answering our questions and ensuring we are well-informed on how the new process will work in practice
- We attended the ND Change Steering Group meeting to discuss the proposed roll out of the new Neurodiversity Profiling Tool across St Helens and the plans for transforming the Neurodevelopmental Assessment Pathway
- We reviewed and shared final comments with Children's Social Care on an easy read document prepared for parent carers to explain how to access social care support for a child with a disability
- We joined the DfE national conversation event to discuss 'early' SEND reform principle with the Schools Minister, Georgia Gould, and a panel of experts as part of a series of events focused on SEND reform ahead of the imminent Schools White Paper which will outline proposed reforms to the SEND system
- We held a coffee morning to chat with other parent carers about what's working well for our children and young people with SEND, what needs improving and what's available to support families of children with SEND and even enjoyed a couple of games of Christmas Bingo!

## **Listen 4 Change: What We've Been Up To in December**

- We attended a project meeting to finalise purchases of sensory toys, assistive/sensory technology and the phases of work scheduled with local suppliers before work commences in January to convert Haydock library into a SEND-friendly library
- We held a meeting with members of a task group from the Children and Young People Services Scrutiny Committee for members of Listen 4 Change to share their perspective on the current state of school SEND provision so that parent carers voices contribute to the Scrutiny review of school places for pupils with SEND considering whether provision is meeting the needs of pupils with SEND
- We manned a market stall at Carmel College's SEND Transition Event to speak with parent carers and professionals about Listen 4 Change and raise awareness of the opportunities for parent carers to have their voices heard so as to improve local services for children and young people with SEND
- We attended a meeting with senior leads to discuss the SEND Strategy workstreams, including a brief update on the transformation of the Neurodevelopmental Assessment Pathway

### **Learning Disability - what support does your child need and what support do they already have?**

Does your child have a learning disability? If yes, we need your help.

Listen 4 Change is involved in a project to establish a Cheshire & Merseyside regional model for diagnosing learning disabilities (LD) and identifying which services are available to support children and young people with a LD diagnosis once a diagnosis has been made.

A learning disability affects general intellectual functioning and day-to-day life. It is lifelong, present from childhood and characterised by significantly reduced intellectual ability (usually an IQ below 70) and impaired social or adaptive functioning. Learning Disability is different from a learning difficulty (such as dyslexia or dyspraxia) which affects learning in specific areas but does not impact overall intelligence or cognitive ability.

To make sure the correct support is in place, the Project Lead wants to know:

What support does your child need?

What support do they have?

What is missing/What do they still need?

## **Youth, Parent & Carer Research Sessions**

The North West Multi-Agency Safeguarding Learning and Support Hub are working on a national piece of research that will shape a new Executive Leadership Course for senior leaders across policing, education, social care, health and community services aiming to support and develop senior leaders in a multi-agency setting to improve outcomes for children and families.

As part of this research, throughout December and January they are running a series of 30–45 minute online or in person youth-friendly engagement sessions using creative, gamified activities and are inviting young people 8–25 and parents and carers to take part.

The sessions will explore what good leadership feels like to young people and families, how leadership behaviours build or break trust, what families need from the people who lead services and how leaders should communicate, listen and involve children, young people and parents.

All contributions are anonymous and no personal case information is collected.

Each participant receives a £30 Amazon voucher but must actively participate in at least 1 of the 3 games.

Help at School: Adaptations & support can be given regardless of a diagnosis. Speak with your SENCO or Teacher.



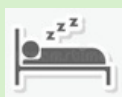

## Let's Clear Up Some Myths!



"Having a diagnosis will give my CYP access to new areas of support."



Nope! Lots of help is there before, during or after being on the Pathway.



"School won't help without a diagnosis."



Schools in St Helens will support based on individual needs using the graduated response.



"My child's referral was rejected by the Pathway, because school doesn't see the differences or didn't fill it in properly."



Non-acceptance is usually due to the Pathway believing that more helpful work can be done with the young person first.



"A diagnosis will mean that my young person can access specialist educational provision."



Access is based on need and not a diagnosis.



"Having a diagnosis of Autism or ADHD will allow my child to access medication."



Medication should be a last resort option and will only be considered after other strategies have been trialled. Medication is not available for, and will not help, with autism.



"A diagnosis will mean my child can get an EHCP."



Also based on need rather than a diagnosis and many CYP, including those with a diagnosis, can be fully supported and understood under their schools universal and SEND provision.
